## PAST MASTERS

They are not infallible, nor are they ever justified in trying to impose their ideas on the Master, but they have had the experience that no one else has had, and such information, discreetly given when requested by the Master, should be most acceptable.

The support of all of the Past Masters is very important and, in most cases, essential to the Master if he is have an outstanding year. The formation of the Past Masters into an Advisory Board by the Master will stimulate in them an incentive to greater interest and more regular attendance and participation in Lodge affairs. Meetings of this group with the Lodge Officers might be arranged whenever deemed most desirable. At such times, the Past Masters' counsel might be solicited concerning any one of a number of varied problems confronting the Lodge. *Handbook for Lodge Officers GL-210*

## CHAPTER 24 PARTICULAR LODGES--BY-LAWS UNIFORM CODE OF BY-LAWS PARTICULAR LODGES

## ELECTION OF OFFICERS

7.02 Manner and Method of Election. - In the election of Officers, nominations shall be made in writing to the Lodge Secretary prior to the opening of the first Stated Communication in December. The written nomination shall also include a statement from the Brother making the nomination that the nominee has agreed to accept the position if elected. Discussions regarding nominees for office may take place among Brethren, but not in open Lodge. A majority of all votes cast, respectively, shall determine. In each succeeding ballot for the same office, when more than two members are voted for, the name or names of the Brother or Brethren having the lowest number of votes, shall, by order of the Master, be dropped; and all votes cast in derogation of said order shall not be counted (2015)





Dear Brethren:

After review by the Elected Grand Lodge Officers and Corporate Board of Directors, please find attached a SUGGESTED Nomination Form for Elective Lodge Office. Listed below are guidelines to aid the Particular Lodge Members in conforming with the changes to Chapter 24, By-Law Section 7.02 Manner and Method of Election that were adopted at the 186th Annual Grand Communication:

• As written, nomination (s) shall be made in writing to the Lodge Secretary for all five (5) elected positions prior to the opening of the first Stated Communication in December.

Note: Nominations may be made in writing any time prior to the formal opening of the Lodge that day or night, but not after the Lodge is opened.

• An election shall not take place for a position for which no one has been nominated.

• Current Elected Lodge Officers must be nominated for the next higher position in order to move forward in the elected line.

- Any Brother may submit a nomination, including self nominations.
- All nominations shall include a statement that the nominee will accept the position if elected.

• A Nomination Committee *may* be appointed by the Worshipful Master, but the appointment of said committee would not preclude others from making nominations.

• The Lodge Secretary or any Brother (such as the Chairman of a Nominating Committee) may actually submit, after verifying they will accept, the nominations for all five (5) positions.

• The Lodge Secretary shall read nominations as received as part of the correspondence reported to the Lodge Members.

• The suggested date to start receiving nominations is October 1st. The Trestleboard is *not recommended* for use in this process.
